Blue #1 – Oakland

From **Q.S.S** - Exit on to **QUINCY**, North on **QUINCY**, East on **6TH**, North on **BRANNER**, East on **SEWARD**, North on **STRAIT**, West on **SARDOU**, South on **KANSAS**, West on **GORDON**, North on **TOPEKA**, East on **MORSE**, North on **EUGENE**, West on **PARAMORE**, North on **TYLER**, East on **LYMAN**, North on **KANSAS**, West on **WALNUT GROVE**, South on **TOPEKA**, West on **US 24**, North on to **WALMART** outer service road, West to **ROCHESTER**, West on **25TH**, North on **25TH**, East on **DILLON'S** outer service road , first exit back on to **25TH**, East on **25TH**, South on **ROCHESTER**, Cross **US 24** to **TYLER**, East on **LYMAN**, South on **KANSAS**, East on **MORSE**, South on **QUINCY** (turns into **KANSAS**), West on **CURTIS FLY OFF**, East on **CURTIS**, North on **KANSAS**, West through **GREAT OVERLAND STATION** lot, West on **CURTIS**, East on **CURTIS FLY OFF**, South on **KANSAS**, East on **8TH**, South on **MONROE** to **QSS - OAKLAND STAGING AREA**.

Orange #2 – Highland Park

From **Q.S.S** - Exit on to **MONROE**, South on **MONROE**, East on **17TH**, South on **ADAMS**, East on **25TH**, South on **CALIFORNIA**, East on **30TH**, South on **SWYGART**, West on **TURNPIKE**, North on **CALIFORNIA**, East on **25TH**, North on **BELLVIEW**, West on **23RD**, North on **CALIFORNIA**, East on **11TH**, North on **GOLDEN**, East on **10TH**, North on **DEER CREEK**, East on **6TH**, South on **RICE**, go through round-about and continue on **RICE**, go around second round-about East on to **CYPRUS**, East on **CYPRUS**, North on **CROCO**, West on **6TH**, South on **MONROE** to **QSS - HIGHLAND PARK STAGING AREA**.

Blue #3 – North Topeka

From **Q.S.S** - Exit on to **QUINCY**, North on **QUINCY**, West on **8TH**, North on **KANSAS**, West on **CURTIS FLY OFF**, East on **CURTIS**, North on **KANSAS**, West through **GREAT OVERLAND STATION** lot, West on **CURTIS**, East on **CURTIS FLY OFF**, North on **KANSAS** (turns into **QUINCY**), West on **FAIRCHILD**, North on **KANSAS**, West on **INDEPENDENCE**, North on **TOPEKA**, East on **LYMAN**, North on **KANSAS**, West on **WALNUT GROVE**, South on **TOPEKA**, West on **US 24**, North on to **WALMART** outer service road, West to **ROCHESTER**, West on **25TH**, North on **25TH**, East on **DILLON'S** outer service road , first exit back on to **25TH**, East on **25TH**, South on **ROCHESTER**, Cross **US 24** to **TYLER**, East on **LYMAN**, South on **TOPEKA**, East on **MORSE** (turns into **SARDOU**), South on **STRAIT**, West on **SEWARD**, South on **BRANNER**, West on **6TH**, South on **MONROE** to **QSS - NORTH TOPEKA STAGING AREA**.

Green #4 – West 10th

From **Q.S.S** - Exit on to **MONROE**, South on **MONROE**, West on **9TH**, North on **QUINCY**, West on **8TH**, South on **WASHBURN**, East on **11TH**, North on **LANE**, West on **10TH**, South on **WANAMAKER**, West on to **WALMART** parking lot to south end of Walmart, East to **WANAMAKER**, South on **WANAMAKER**, East on **21ST**, South on **GAGE**, Enter **VA HOSPITAL SOUTH ENTRANCE**, East on **ROAD D**, North on **ROAD A** (turns into **ROAD K**), East on **ROAD A**, North on **ARNOLD**, East on **21ST**, North on **KANSAS**, East on **12TH**, North on **QUINCY** to **QSS - WEST 10TH STAGING AREA**.

Green #4S – West 10th Special

From T. H. S. bus stop at **10TH** and **TAYLOR**, East on **10TH**, East on **I-70**, South on **CALIFORNIA**, East on **25TH**, North on **BELLVIEW**, West on **23RD**, North on **CALIFORNIA**, West on **I-70**, West on **8TH**, South on **MONROE** to **QSS - WEST 29TH SPECIAL STAGING AREA**.

Purple #5 – West 6th

From **Q.S.S** - Exit on to **QUINCY**, North on **QUINCY**, West on **6TH**, South on **CORPORATE VIEW**, East on **6TH**, South on **WANAMAKER**, West on to **WALMART** parking lot to south end of Walmart, East to **WANAMAKER**, South on **WANAMAKER**, West on **17TH**, North on **ARVONIA**, East on **HUNTOON**, South on **POLK**, East on **14TH**, North on **TYLER**, East on **HUNTOON**, North on **TOPEKA**, East on **10TH**, North on **QUINCY**, East on **8TH**, South on **MONROE** to **QSS - WEST 6TH STAGING AREA**.

Red #6 – West 17th

From **Q.S.S** - Exit on **9TH**, West on **9TH**, South on **QUINCY**, West on **10TH**, South on **TOPEKA**, West on **17TH**, South on **STONE**, West on **18TH**, North on **GAGE**, West on **17TH**, North on **WANAMAKER**, West on **WINDING ROAD**, South on outer service road through **WALMART** parking lot, West to **SOUTH END OF WALMART**, East to **WANAMAKER**, South on **WANAMAKER**, East on **29TH**, North on **KANSAS**, East on **12TH**, North on **QUINCY**, East on **8TH**, South on **MONROE** to **QSS - WEST 17TH STAGING AREA**.

Purple #7 – Huntoon

From **Q.S.S** - Exit on to **MONROE**, South on **MONROE**, West on **10TH**, South on **TOPEKA**, West on **12TH** (turns into **HUNTOON**), West on **HUNTOON**, South on **WANAMAKER**, West on to **WALMART** parking lot to south end of Walmart, East to **WANAMAKER**, South on **WANAMAKER**, West on **17TH**, North on **ARVONIA**, East on **HUNTOON**, North on **WANAMAKER**, West on **6TH**, South on **CORPORATE VIEW**, East on **6TH**, South on **MONROE**, West on **9TH**, North on **QUINCY** to **QSS - HUNTOON STAGING AREA**.

Yellow #8 – South California

From **Q.S.S** - Exit on to **MONROE**, South on **MONROE**, West on **9TH**, North on **QUINCY**, East on **8TH**, North on **JEFFERSON**, East on **6TH**, South on **BRANNER TRAFFICWAY**, East on **10TH**, South on **CALIFORNIA**, West on **29TH**, South on **INDIANA**, West on **35TH TERRACE**, North on **ADAMS**, West on **GOLF PARK**, South on **FREMONT** to **33RD TERRACE**, South on **33RD TERRACE** to **GIRARD**, East on **GIRARD** to **37TH**, West on **37TH**, South on **TOPEKA**, West on **38TH** on to **WALMART** parking lot, exit West Walmart exit onto **37TH**, East on **37TH**, North on **TOPEKA**, West on **27TH**, North on **BUCHANAN**, East on **21ST**, North on **TOPEKA**, East on **10TH**, North on **QUINCY** to **QSS - SOUTH CALIFORNIA STAGING AREA**.

Red #9 – West 29th

From **Q.S.S** - Exit on to **MONROE**, South on **MONROE**, West on **12TH**, South on **KANSAS**, West on **29TH**, North on **VILLA WEST DRIVE**, East on **25TH**, North on **WESTPORT DRIVE**, West on **22ND PARK**, North on **WANAMAKER**, West on **21ST** to **WESTRIDGE MALL WEST ENTRANCE**, North to **BOARDING AREA AT SOUTHWEST MALL ENTRANCE**, North on outer **SERVICE ROAD**, North on **ARVONIA**, East on **17TH**, South on **GAGE**, East on **18TH**, North on **STONE**, East on **17TH**, North on **TOPEKA**, East on **10TH**, North on **QUINCY**, East on **9TH** to **QSS - WEST 29TH STAGING AREA**.

Green #10 – West 21st

From **Q.S.S** - Exit on to **QUINCY**, North on **QUINCY**, East on **8TH**, South on **MONROE**, West on **17TH**, South on **KANSAS**, West on **21ST**, South in to **VA** at **ARNOLD**, West on **ROAD A**, West on **ROAD D**, North on **GAGE**, West on **21ST** to **WESTRIDGE MALL WEST ENTRANCE**, North to **BOARDING AREA AT SOUTHWEST MALL ENTRANCE**, North on **SERVICE ROAD**, North on **ARVONIA**, East on **17TH**, North on **WANAMAKER**, East on **10TH**, North on **LANE**, East on **8TH**, South on **MONROE** to **QSS - WEST 21ST STAGING AREA**.

Orange #11 – East 6th

From **Q.S.S** - Exit on to **9TH**, West on **9TH**, North on **QUINCY**, East on **6TH**, South on **GOLDEN**, East on **10TH**, North on **DEER CREEK**, East on **6TH**, South on **RICE**, go through round-about and continue on **RICE**, go around second round-about East on to **CYPRUS**, East on **CYPRUS**, South on **CROCO**, West on **29TH**, South on **CALIFORNIA**, East on **30TH**, South on **SWYGART**, West on **TURNPIKE**, North on **CALIFORNIA**, East on **25TH**, North on **BELLVIEW**, West on **23RD**, North on **CALIFORNIA**, West on **21ST**, North on **HUDSON**, West on **15TH**, North on **KANSAS**, East on **8TH**, South on **MONROE** to **QSS - EAST 6TH STAGING AREA**.

Yellow #12 – White Lakes

From **21ST** and **WESTPORT** - South on **WESTPORT**, East on **25TH**, South on **ARROWHEAD**, East on **33RD**, South on **BELLE**, East on **37TH**, North on **CHELSEA**, East on **34TH**, North on **FAIRLAWN**, East on **I-470**, South on **GAGE**, West on **33RD**, South on **EVENINGSIDE**, East on **35TH**, North on **GAGE**, East on **TWILIGHT**, North on **ARNOLD**, East on **29TH TERRACE**, South on **OAKLEY**, East on **33RD**, North on **MACVICAR**, East on **30TH**, North on **BURLINGAME**, East on **29TH**, North on **KANSAS**, East on **8TH**, South on **MONROE** to **QSS WEST 29TH SPECIAL** staging area, exit on to **9TH**, West on **9TH**, North on **QUINCY**, East on **8TH**, North on **MADISON**, West on **1ST** (to Ameripride).
