Bob said that we've had two morale issue meetings and he does think they're in a good place. We're asking "why?" We've gone through two meetings and nobody's walked out yet. So, things are good right now. Fatima asked about The Ticker. Bob said we're still trying to perfect it and we're still having some issues with it over the last week. We're trying to fill the information void so they know and won't put whatever they want to put in that void. So, we're getting somewhere, and I think we have the right players at the right time to accomplish something. The question in our minds is will we come to some accord and we have a better working relationship and then all of the sudden they elect new officers. Candis said that the officers come from their ranks, so if you can get the ranks happy, it shouldn't be so much of a task. Bob said that therein lies the problem with the last contract negotiation.
