- 2. Install 1/2" HD ISO coverboard common fastened thru existing EPDM, ISO and crickets into metal deck using 16 fasteners per 4x8 cover board
- 3. Adhere .135 mil Fleeceback TPO in white per manufactures specifications terminated with termination bar under new coping skirt flashing, termination bar under existing 2-piece Reglet, and new white drip edge in standard colors
- 4. Install required premanufactured TPO accessories

- 2. Shop fabricate and install prefinished 24-guage TPO coated drip edge in white

Exclusions

- 1. Wood blocking/ wall sheathing
- 2. Replacement of wet insulation
- 3. Vapor retarder & deck sheathing
- 4. Gutter and downspouts
- 5. Removal or replacement of coping, wall panels and associated trims
- 6. Adhered insulation layers
- 7. Roof walkway layout (not indicated on plans)
- 8. Temporary Roofing
- 9. Equipment screen wall structure / screen wall panels
- 10. Non-roof related brake metal flashing at thru-walls, openings, and sills/ledges
- 11. Custom/ Premium sheet metal colors
- 12. Curbs/Roof Hatch/Ladder-Up Post/Roof Hatch Safety Rail/Ladder to Roof Hatch
- 13. Third party testing/inspections/engineering

Notes:

- This roof assembly was bid as an adhered Fleeceback TPO assembly
- 25- and 30-year warranties require us to terminate using termination bar in lieu of removing and reinstalling coping
- Specifications for mechanical units do not indicate if supply lines will be internal or external. This proposal is based upon an internal line design.
- Any deficiencies or unforeseen issues found during the course of work pertaining to framing, substrate, plumbing, electrical, mechanical, masonry, or detection of moisture, will be brought to the owner's attention - Any scope or cost associated changes will be proposed with a change order generated by Alpha Roofing
- Alpha Roofing will manage roof top materials and debris containment
- Owner allows the right of way use for parking, lift equipment, dumpsters, generators, and other work-related equipment
- Price is based on a temperature installation above 40 degrees Fahrenheit. If temperatures drop below 40 degrees Fahrenheit, the installation will require a "cold weather" application and a change order will be generated for the alternate material cost
- Alpha Roofing is not responsible for incidental sitework damage
- Waste dumpsters provided by Alpha Roofing
- All taxes excluded
