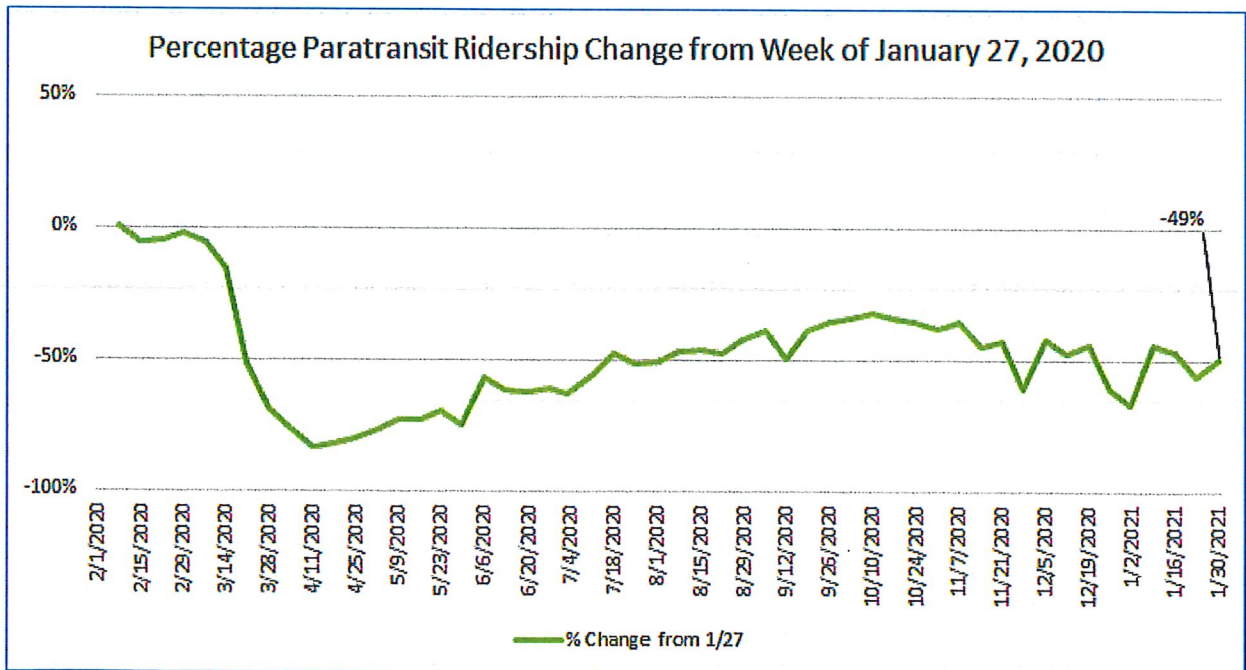
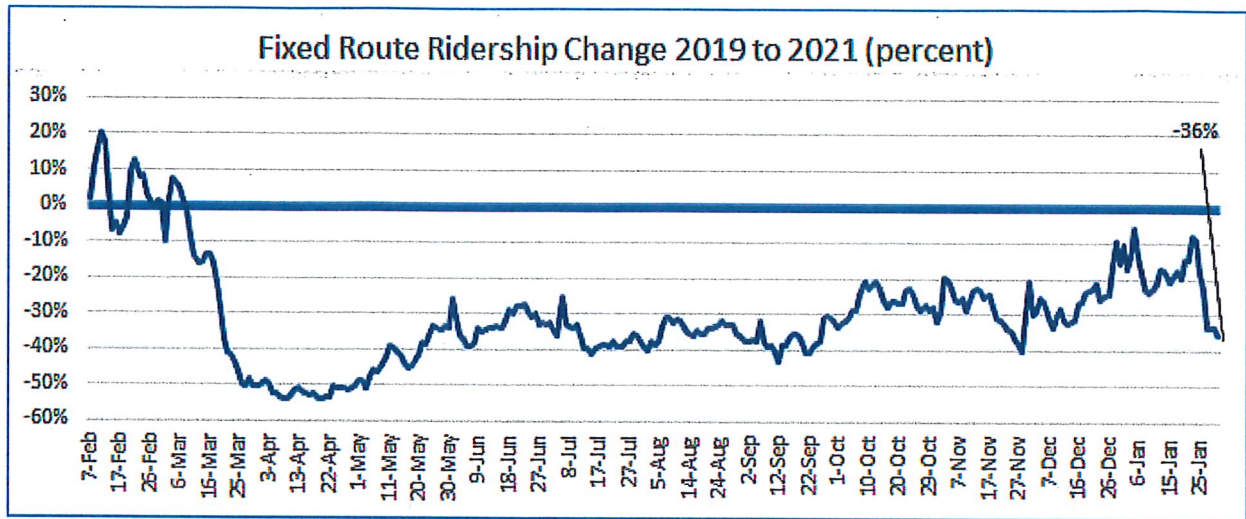


# Planning Board Report

## Ridership Table Notes

- Line 28: Note the total paratransit service is down almost 40% Fiscal Year to Date. This continued lack of demand could be due to behavior shift to alternatives like grocery delivery for those using paratransit for grocery
- Fixed Route Ridership has dropped 27% as compared to 2019 in the last week of January. This looks to be one of the longest, most steep drops since March 2020 and the beginning of the Pandemic.
