Turn-by-turn Route Descriptions

#1 – Oakland

Outbound from **Q.S.S.** – Exit on to **QUINCY**, Right on **QUINCY**, Right on **6TH**, Left on **BRANNER TRAFFICWAY**, Right on **SEWARD**, Left on **STRAIT**, Left on **SARDOU** (turns into **MORSE**), continue on **MORSE**, Right on **TOPEKA**, Left on **LYMAN**, Right on **TYLER**, Cross **US 24** to **ROCHESTER**, Left on **FRONTAGE RD/BIS** to **DILLON’S NORTH**, Right on **FRONTAGE RD/BIS**, Right on **CLAY**, Right on **25TH** to **ALDI NORTH**.

Inbound from **ALDI NORTH** — Continue on **25TH**, Left on **DILLON’S NORTH** outer service road (BIS RD), Right on **ROCHESTER**, Cross **US 24** to **TYLER**, Left on **TYLER**, Right on **LYMAN**, South on **TOPEKA**, Left on **MORSE** (turns into **SARDOU**), continue on **SARDOU**, Right on **STRAIT**, Right on **SEWARD**, Left on **BRANNER TRAFFICWAY**, Right on **6TH**, Left on **MONROE**, Right into **North Entrance** to **Q.S.S**

#2 – North Kansas

Outbound from **Q.S.S.** – Exit on to **QUINCY**, Right on **QUINCY**, Left on **6TH**, Right on **KANSAS**, Left on **CURTIS FLYOFF**, Right on **CURTIS**, Left on **KANSAS**, Left into **GREAT OVERLAND STATION** lot, Left out of **Station** lot, Right on **CURTIS**, Left on **CURTIS FLYOFF**, Left on **KANSAS** (turns into **QUINCY**), continue on **QUINCY**, Left on **MORSE**, Right on **KANSAS**, Left on **INDEPENDENCE**, Right on **TOPEKA**, Right on **LYMAN**, Left on **KANSAS**, Cross **US 24** to **KANSAS**, Left on **WALNUT GROVE DR**, Left on **TOPEKA**, Right on **US 24**, Right at entrance to **WALMART NORTH**, Left to **Walmart North** , onto outer **FRONTAGE RD/BIS** across **Rochester** to **DILLON’S NORTH**, Right on **FRONTAGE RD/BIS**, Right on **CLAY**, Right to **25TH** to **ALDI NORTH**.

Inbound from **ALDI NORTH** – Continue on **25TH**, Left on **DILLON’S NORTH** outer service road (BIS RD), Right on **ROCHESTER**, Left on **US 24** (take **North** on cloverleaf), Right on **TOPEKA**, Right on **WALNUT GROVE DR**, Right on **KANSAS**, Cross **US 24** to **KANSAS**, Right on **LYMAN**, Left on **TOPEKA**, Left on **INDEPENDENCE**, Right on **KANSAS**, Left on **MORSE**, Right on **QUINCY** (turns into **KANSAS**), Left on **KANSAS**, Right on **CURTIS FLYOFF**, Right on **CURTIS**, Left on **KANSAS**, Left into **GREAT OVERLAND STATION** lot, Left out of **Station** lot, Right on **CURTIS**, Left on **CURTIS FLYOFF**, Right on **KANSAS**, Left on **6TH**, Right on **MONROE**, Right into **North Entrance** to **Q.S.S**

#3 – East 6th *(interlined with West 6th Route)*

Outbound from **Q.S.S.** – Exit on to **QUINCY**, Right on **QUINCY**, Right on **6TH**, Right on **GOLDEN**, Left on **10TH**, Left on **DEER CREEK PKWY**, Right on **6TH**, Left on **CROCO** to the “Receiving” entrance of the new Reser’s plant (furthest Left entrance off **CROCO**), turn around in the Reser’s parking lot, turn Right on **CROCO**.

Inbound from **6TH & CROCO** –Right on **6TH**, Left on **MONROE**, Right into **South Entrance** to Stage as **West 6TH** @ **Q.S.S**

#4 – California

Outbound from **Q.S.S.** – Exit on to **QUINCY**, Right on **QUINCY**, Right on **6TH**, Right on **BRANNER TRAFFICWAY**, Left on **10TH**, Right on **CALIFORNIA**, Left into **WALMART EAST PARKING LOT** (at the stop light), follow outer service road around lot to the **WALMART BUS STAGING LOCATION** on the North side of the store, continue Left and then North through to lot to **25TH**, Right on **25TH**, Left on **HIGHLAND**, Left on **23RD**, Left on **BELLVIEW**, Right on **25TH**, Left on **CALIFORNIA**, Right on **29TH**, Left on **ADAMS**, Right on **GOLF PARK BLVD**, Left on **COLFAX** to **AVONDALE CRC**.

Inbound from **AVONDALE CRC** – South on **COLFAX**, Left on **33RD TERRACE**, Left on **ADAMS**, Right on **29TH**, Right on **CALIFORNIA**, Left on **30TH**, Right on **SWYGART**, Right on **TURNPIKE**, Right on **CALIFORNIA**, Right into **WALMART EAST PARKING LOT** (at the stop light), follow outer service road around lot to the **WALMART BUS STAGING LOCATION** on the North side of the store, continue Left and then North through to lot **25TH**, Right on **25TH**, Left on **BELLVIEW**, Left on **23RD**, Right on **CALIFORNIA**, Left on **10TH**, Right on **BRANNER TRAFFICWAY**, Left on **6TH**, Left on **MONROE**, Right into **North Entrance** to **Q.S.S.**

#5 – Indiana

Outbound from **Q.S.S.** – Exit on to **MONROE**, Right on **MONROE**, Left on **17TH** (turns into 15th Street at Adams), Right on **ADAMS**, Left on **21ST**, Right on **INDIANA**, Right on **37TH**, Left on **TOPEKA BLVD**, Right on **38TH** (back side of Walmart South), Right on **39TH** (becomes **MARTIN DRIVE**), continue on **MARTIN DRIVE**, Right on **42ND**, Right on **BURLINGAME**, Left on **37TH**, Right on **GAGE**, Left on **33RD TERR**.

Inbound from **33RD TERR & ARROWHEAD** – West on **33RD TERR**, Left on **EVENINGSIDE**, Left on **35TH**, Right on **GAGE**, Left on **37TH**, Left on **INDIANA**, Left on **21ST**, Right on **ADAMS**, Left on **15TH** (turns into 17th Street after Adams), Right on **KANSAS**, Right on **10TH**, Left on **QUINCY**, Right into **Q.S.S**

#6 – West 6th (interlined with East 6th Route)

Outbound from **Q.S.S.** – Exit on to **9TH**, Right on **9TH**, Right on **QUINCY**, Left on **6TH**, take round-about which continues **6TH**, Right on **6TH**, Left on **CORPORATE VIEW** (follow back around to **6TH**), Right on **6TH**, Right on **WANAMAKER** to road between Golden Corral and convenience store, Right into **WALMART WEST** parking lot to transfer center at south end of store.

Inbound from **WALMART WEST** – Circle back Right to **WANAMAKER**, Right on **WANAMAKER**, Right on **17TH**, Right on **ARVONIA**, Right on **HUNTOON**, Left on **WANAMAKER**, take round-about which turns into **6TH**, Right on **6TH**, Left on **OAKLEY**, Right on **3RD**, Right on **MACVICAR**, Left on **6TH**, Right on **MONROE**, Right into **North Entrance** to Stage as **East 6th @ Q.S.S.**

#7 – Washburn

Outbound from **Q.S.S.** – Exit on to **9TH**, Right on **9TH**, Right on **QUINCY**, Left on **8TH**, Left on **WASHBURN** (becomes Burlingame), Left on **29TH**, Right on **TOPEKA BLVD**, Right on **38TH** (back side of Walmart South), Right on **39TH** (becomes Martin Drive, continue), on **MARTIN DRIVE**, Right on **42ND** to **TARC SOUTHGATE**.

Inbound from **TARC SOUTHGATE** – West on **42ND**, Right on **BURLINGAME**, Right on **37TH**, Left on **TOPEKA**, Left on **29TH**, Right on **BURLINGAME** (turns into **WASHBURN** and then into **LANE**), continue **LANE**, Right on **8TH**, Right on **MONROE**, Right into **South Entrance** to **Q.S.S.**

#10 – West 10th

Outbound from **Q.S.S.** – Exit on to **MONROE**, Right on **MONROE**, Right on **10TH**, Left on **WANAMAKER** to road between Golden Corral and convenience store, Right into **WALMART WEST** parking lot to transfer center at south end of store, circle back Right to **WANAMAKER**, Right on **WANAMAKER** to first entrance into **WEST RIDGE MALL**, right on the service road to Northside of the mall parking lot to bus stop located before **ARVONIA**.

Inbound from **WEST RIDGE MALL** – Right on **ARVONIA**, Right on **17TH**, Left on **WANAMAKER**, Right on **10TH**, Left on **QUINCY**, Right on **9TH** into **Q.S.S.**

#12 – Huntoon

Outbound from **Q.S.S.** – Exit on to **MONROE**, Right on **MONROE**, Right on **12TH**, Left on **POLK**, Left on **13TH**, Left on **TYLER**, Left on **12TH** (turns into Huntoon), Right on **HUNTOON**, Left on **WANAMAKER** to road between Golden Corral and convenience store, Right into **WALMART WEST** parking lot to transfer center at south end of store.

Inbound from **WALMART WEST** – Circle back Right to **WANAMAKER**, Right on **WANAMAKER**, Right on **17TH**, Right on **ARVONIA**, Right on **HUNTOON**, Right on **POLK**, Left on **13TH**, Left on **TYLER**, Right on **HUNTOON** (Turns into **12TH**), continue **12TH**, Left on **QUINCY**, Right into **Q.S.S.**

#17 - West 17th

Outbound from **Q.S.S.** – Exit on to **9TH**, Right on **9TH**, Right on **QUINCY**, Left on **8TH**, Left on **TOPEKA**, Right on **17TH**, Left on **STONE**, Right on **18TH**, Right on **GAGE**, Left on **17TH**, Right on **WANAMAKER** to road between Golden Corral and convenience store, Left into **WALMART WEST** parking lot to transfer center at south end of store.

Inbound from **WALMART WEST** – Circle back Right to **WANAMAKER**, Right on **WANAMAKER** to first entrance into **WEST RIDGE MALL**, right on the service road through the mall parking lot to bus stop located Northside of mall parking lot bus stop located **ARVONIA**, Right on **ARVONIA**, Right on **17TH (SEE DEVIATION BELOW)**, Right on **GAGE**, Left on **18TH**, Left on **STONE**, Right on **17TH**, Left on **TOPEKA**, Right on **8TH**, Right on **MONROE**, Right into **South Entrance** into **Q.S.S.**

(ROUTE DEVIATION: *the route will deviate during the school year by the Hope Street Academy weekdays **only on the inbound route** once in the morning (6:45 a.m. run only) and once in the afternoon (2:45 p.m. run only). The route deviation will be Right on **17TH**, Right on **HOPE**, Left on **19TH** to **GREEN ACRES**, Left on **GREEN ACRES** to **17TH**, Right on **17TH**, and back on route.)*

#21 – West 21st

Outbound from **Q.S.S.** – Exit on to **MONROE**, Right on **MONROE**, Right on **17TH**, Left on **KANSAS**, Right on **21ST**, Left into **VA** at **Rd N/ARNOLD**, Right on **ROAD K**, Left on **ROAD A**, Right on **ROAD D**, Right on **GAGE**, Left on **21ST**, Right to the first **WEST RIDGE MALL ENTRANCE**, Right on outer service road on to Northside of mall parking lot bus stop located before **ARVONIA**.

Inbound from **WEST RIDGE MALL** – Right on **ARVONIA**, Right on **17TH**, Right on **WANAMAKER**, Left on **21ST**, Right on **GAGE**, Enter **VA HOSPITAL SOUTH ENTRANCE**, Left on **ROAD D**, Left on **ROAD A**, Right on **ROAD K**, Left on **Road N**, Right on **21ST**, Left on **KANSAS**, Right on **10TH**, Left on **QUINCY**, Right into **Q.S.S.**

NOTE: *A single inbound run starts at 3:15 p.m. at the **21st and Belle bus stop**.*

#29 – West 29th

Outbound from **Q.S.S.** – Exit on to **MONROE**, Right on **MONROE**, Right on **12TH**, Left on **KANSAS**, Right on **29TH**, Right on **VILLA WEST DRIVE**, Right on **27TH**, Right on **WANAMAKER**, Right on **29TH** to round-about at **URISH**.

Inbound from **29TH & URISH** – East on **29TH**, Left on **KANSAS**, Right on **12TH**, Right on **9TH**, Right on **QUINCY**, Left into **Q.S.S.**
