

# Topeka Metro

## Turn-by-turn Route Descriptions

### #1 – Oakland

Outbound from **Q.S.S.** – Exit on to **QUINCY**, North on **QUINCY**, East on **6TH**, North on **BRANNER TRAFFICWAY**, East on **SEWARD**, North on **STRAIT**, West on **SARDOU** (turns into **MORSE**), West on **MORSE**, North on **TOPEKA**, West on **LYMAN**, North on **TYLER**, Cross **US 24** to **ROCHESTER**, West on **FRONTAGE RD/BIS** to **DILLON’S NORTH**, West on **FRONTAGE RD/BIS**, North on **CLAY**, East on **25TH** to **ALDI NORTH**.

Inbound from **ALDI NORTH** – Continue East on **25TH**, East on **DILLON’S NORTH** outer service road (BIS RD), South on **ROCHESTER**, Cross **US 24** to **TYLER**, South on **TYLER**, East on **LYMAN**, South on **TOPEKA**, East on **MORSE** (turns into **SARDOU**), East on **SARDOU**, South on **STRAIT**, West on **SEWARD**, South on **BRANNER TRAFFICWAY**, West on **6TH**, South on **MONROE** into **North Entrance @ Q.S.S.**

### #2 – North Kansas

Outbound from **Q.S.S.** – Exit on to **QUINCY**, North on **QUINCY**, West on **6TH**, North on **KANSAS**, West on **CURTIS FLYOFF**, East on **CURTIS**, North on **KANSAS**, West through **GREAT OVERLAND STATION** lot, West on **CURTIS**, East on **CURTIS FLYOFF**, North on **KANSAS** (turns into **QUINCY**), North on **QUINCY**, West on **MORSE**, North on **KANSAS**, West on **INDEPENDENCE**, North on **TOPEKA**, East on **LYMAN**, North on **KANSAS**, Cross **US 24** to **KANSAS**, West on **WALNUT GROVE DR**, South on **TOPEKA**, West on **US 24**, North on to **WALMART NORTH** outer service road, West to **ROCHESTER**, West on **FRONTAGE RD/BIS** to **DILLON’S NORTH**, West on **FRONTAGE RD/BIS**, North on **CLAY**, East on **25TH** to **ALDI NORTH**.

Inbound from **ALDI NORTH** – Continue East on **25TH**, East on **DILLON’S NORTH** outer service road (BIS RD), South on **ROCHESTER**, East on **US 24** (take **NB** Ramp on cloverleaf), North on **TOPEKA**, East on **WALNUT GROVE DR**, South on **KANSAS**, Cross **US 24** to **KANSAS**, West on **LYMAN**, South on **TOPEKA**, East on **INDEPENDENCE**, South on **KANSAS**, East on **MORSE**, South on **QUINCY** (turns into **KANSAS**), South on **KANSAS**, West on **CURTIS FLYOFF**, East on **CURTIS**, North on **KANSAS**, West through **GREAT OVERLAND STATION** lot, West on **CURTIS**, East on **CURTIS FLYOFF**, South on **KANSAS**, East on **6TH**, South on **MONROE** into **North Entrance @ Q.S.S.**

### #3 – East 6<sup>th</sup> *(interlined with West 6<sup>th</sup> Route)*

Outbound from **Q.S.S.** – Exit on to **QUINCY**, North on **QUINCY**, East on **6TH**, South on **GOLDEN**, East on **10TH**, North on **DEER CREEK PKWY**, East on **6TH**, North on **CROCO** to the “Receiving” entrance of the new Reser’s plant (furthest North entrance off **CROCO**), turn around in the Reser’s parking lot, turn South on **CROCO**.

Inbound from **6TH & CROCO** – West on **6TH**, South on **MONROE** to **South Entrance Stage in West 6TH @ Q.S.S.**

#### #4 – California

Outbound from **Q.S.S.** – Exit on to **QUINCY**, North on **QUINCY**, East on **6TH**, South on **BRANNER TRAFFICWAY**, East on **10TH**, South on **CALIFORNIA**, East into **WALMART EAST PARKING LOT** (at the stop light), follow outer service road around lot to the **WALMART BUS STAGING LOCATION** on the North side of the store, continue East and then North through lot to **25TH**, East on **25TH**, North on **HIGHLAND**, West on **23RD**, South on **BELLVIEW**, West on **25TH**, South on **CALIFORNIA**, West on **29TH**, South on **ADAMS**, West on **GOLF PARK BLVD**, South on **COLFAX** to **AVONDALE EAST**.

Inbound from **AVONDALE EAST** – South on **COLFAX**, East on **33<sup>RD</sup> TERRACE**, North on **ADAMS**, East on **29TH**, South on **CALIFORNIA**, East on **30TH**, South on **SWYGART**, West on **TURNPIKE**, North on **CALIFORNIA**, East into **WALMART EAST PARKING LOT** (at the stop light), follow outer service road around lot to the **WALMART BUS STAGING LOCATION** on the North side of the store, continue East and then North through lot to **25TH**, East on **25TH**, North on **BELLVIEW**, West on **23RD**, North on **CALIFORNIA**, West on **10TH**, North on **BRANNER TRAFFICWAY**, West on **6TH**, South on **MONROE** to **North Entrance @ Q.S.S.**

#### #5 – Indiana

Outbound from **Q.S.S.** – Exit on to **MONROE**, South on **MONROE**, East on **17TH** (turns into 15<sup>th</sup> Street at Adams), South on **ADAMS**, East on **21ST**, South on **INDIANA**, West on **37TH**, South on **TOPEKA BLVD**, West on **38TH** (back side of Walmart South), West on **39TH** (becomes **MARTIN DRIVE**), South on **MARTIN DRIVE**, West on **42ND**, North on **BURLINGAME**, West on **37TH**, North on **GAGE**, West on **33RD TERR.**

Inbound from **33RD TERR & ARROWHEAD** – West on **33RD**, South on **EVENINGSIDE**, East on **35TH**, South on **GAGE**, East on **37TH**, North on **INDIANA**, West on **21ST**, North on **ADAMS**, West on **15TH** (turns into 17<sup>th</sup> Street after Adams), North on **KANSAS**, East on **10TH**, North on **QUINCY** into **Q.S.S.**

#### #6 – West 6<sup>th</sup> *(interlined with East 6<sup>th</sup> Route)*

Outbound from **Q.S.S.** – Exit on to **9TH**, West on **9TH**, North on **QUINCY**, West on **6TH**, take round-about which continues **6TH**, West on **6TH**, South on **CORPORATE VIEW** (follow back around to **6TH**), East on **6TH**, South on **WANAMAKER** to road between Golden Corral and convenience store, West into **WALMART WEST** parking lot to transfer center at south end of store.

Inbound from **WALMART WEST** – Circle back East to **WANAMAKER**, South on **WANAMAKER**, West on **17TH**, North on **ARVONIA**, East on **HUNTOON**, North on **WANAMAKER**, take round-about which turns into **6TH**, East on **6TH**, North on **OAKLEY**, East on **3RD**, South on **MACVICAR**, East on **6TH**, South on **MONROE** to **North Entrance Stage in East 6TH @ Q.S.S.**

## **#7 – Washburn**

Outbound from **Q.S.S.** – Exit on to **9TH**, West on **9TH**, North on **QUINCY**, West on **8TH**, South on **WASHBURN** (becomes Burlingame), East on **29TH**, South on **TOPEKA BLVD**, West on **38TH** (back side of Walmart South), West on **39TH** (becomes Martin Drive), South on **MARTIN DRIVE**, West on **42ND** to **TARC SOUTHGATE**.

Inbound from **TARC SOUTHGATE** – West on **42ND**, North on **BURLINGAME**, East on **37TH**, North on **TOPEKA**, West on **29TH**, North on **BURLINGAME** (turns into **WASHBURN** and then into **LANE**), North on **LANE**, East on **8TH**, South on **MONROE** into **South Entrance @ Q.S.S.**

## **#10 – West 10<sup>th</sup>**

Outbound from **Q.S.S.** – Exit on to **MONROE**, South on **MONROE**, West on **10TH**, South on **WANAMAKER** to road between Golden Corral and convenience store, West into **WALMART WEST** parking lot to transfer center at south end of store, circle back East to **WANAMAKER**, South on **WANAMAKER** to first entrance into **WEST RIDGE MALL**, west on the service road to the Northside mall parking lot to bus stop located before **ARVONIA**.

Inbound from **WEST RIDGE MALL** – North on **ARVONIA**, East on **17TH**, North on **WANAMAKER**, East on **10TH**, North on **QUINCY**, East on **9TH** into **Q.S.S.**

## **#12 – Huntoon**

Outbound from **Q.S.S.** – Exit on to **MONROE**, South on **MONROE**, West on **12TH**, South on **POLK**, East on **13TH**, North on **TYLER**, West on **12TH** (turns into Huntoon), West on **HUNTOON**, South on **WANAMAKER** to road between Golden Corral and convenience store, West into **WALMART WEST** parking lot to transfer center at south end of store.

Inbound from **WALMART WEST** – Circle back East to **WANAMAKER**, South on **WANAMAKER**, West on **17TH**, North on **ARVONIA**, East on **HUNTOON**, South on **POLK**, East on **13TH**, North on **TYLER**, East on **HUNTOON** (Turns into **12TH**), East on **12TH**, North on **QUINCY** into **Q.S.S.**

## **#17 – West 17<sup>th</sup>**

Outbound from **Q.S.S.** – Exit on to **9TH**, West on **9TH**, North on **QUINCY**, West on **8TH**, South on **TOPEKA**, West on **17TH**, South on **STONE**, West on **18TH**, North on **GAGE**, West on **17TH**, North on **WANAMAKER** to road between Golden Corral and convenience store, West into **WALMART WEST** parking lot to transfer center at south end of store.

Inbound from **WALMART WEST** – Circle back East to **WANAMAKER**, South on **WANAMAKER** to first entrance into **WEST RIDGE MALL**, west on the service road through the mall parking lot to bus stop located before **ARVONIA**, North on **ARVONIA**, East on **17TH (SEE DEVIATION BELOW)**, South on **GAGE**, East on **18TH**, North on **STONE**, East on **17TH**, North on **TOPEKA**, East on **8TH**, South on **MONROE** into **South Entrance @ Q.S.S.**

***(ROUTE DEVIATION:** the route will deviate during the school year by the Hope Street Academy weekdays **only on the inbound route** once in the morning (6:45 a.m. run only) and once in the afternoon (2:45 p.m. run only). The route deviation will be East on **17TH**, South on **HOPE**, East on **19TH** to **GREEN ACRES**, North on **GREEN ACRES** to **17TH**, East on **17TH**, and back on route.)*

## **#21 – West 21<sup>st</sup>**

Outbound from **Q.S.S.** – Exit on to **MONROE**, South on **MONROE**, West on **17TH**, South on **KANSAS**, West on **21ST**, South into **VA** at **RD N/ARNOLD**, West on **ROAD K**, South on **ROAD A**, West on **ROAD D**, North on **GAGE**, West on **21ST** to the first **WEST RIDGE MALL ENTRANCE**, follow outer service road on to Northside of mall to the bus stop located before **ARVONIA**.

Inbound from **WEST RIDGE MALL** – North on **ARVONIA**, East on **17TH**, South on **WANAMAKER**, East on **21ST**, South on **GAGE**, Enter **VA HOSPITAL SOUTH ENTRANCE**, East on **ROAD D**, North on **ROAD A**, East on **ROAD K**, North on **ROAD N**, East on **21ST**, North on **KANSAS**, East on **10TH**, North on **QUINCY** into **Q.S.S.**

**NOTE:** A single inbound run starts at 3:15 p.m. at the **21<sup>st</sup> and Belle bus stop**.

## **#29 – West 29<sup>th</sup>**

Outbound from **Q.S.S.** – Exit on to **MONROE**, South on **MONROE**, West on **12TH**, South on **KANSAS**, West on **29TH**, North on **VILLA WEST DRIVE**, East on **27TH**, South on **WANAMAKER**, West on **29TH** to round-about at **URISH**.

Inbound from **29TH & URISH** – East on **29TH**, North on **KANSAS**, East on **12TH**, North on **QUINCY**, East on **9TH** into **Q.S.S.**
