



JM Smuckers Trailer Drop Lot

TGB Group provided the Civil Engineering design for the The JM Smuckers Company Trailer Drop Lot Expansion to construct a new trailer parking lot to hold 114 semi-trailers for their 105 Acre Site. The new Trailer Drop Lot of approximately 3 acres of new pavement was constructed to allow trailers to be stored for the Distribution Center for JM Smucker Company in the City of Topeka, Kansas. The project was under a unique situation where \$1.7 million of funds were available and could be allocated by JM Smuckers if the funds were able to be spent to provide design, get all City approvals necessary, and construction completed within 3-1/2 months. City officials, the contractor, & TGB Group immediately set up meetings to formulate a plan and schedule to be able to make it happen so that JM Smuckers could allocate the funds to the project so it would allow \$1.7 million to be spent in the community. All parties involved worked cohesively to make the project happen. TGB Group provided the topographic survey, site/civil design services for the 3-acre drop lot, stormwater drainage design including water quantity and quality design, stormwater management plan, instrument easements, and construction staking for project.

- Design of 3-Acre Trailer Drop Lot to provide 114 spaces for Semi-Trailer storage for the JM Smuckers Distribution Center.
- Design of Water Quality Infiltration Basin to provide stormwater runoff treatment for all areas developed since 2008.
- Drainage Analysis for the entire 105 Acre site to determine the adequacy of the existing Detention Pond constructed in 2008 when the Distribution Center was constructed.
- Detention Pond Design Improvements to allow for additional capacity for all development since 2008 and to improve spillways to and berms to bring them up to current City Standards.
- Fast Tracking of the Project by working closely with Contractor, City Officials, and Owner to provide a great project for the Community and JM Smucker Company.
- The project design was completed in February 2019 and construction started in February 2019 and completed in April 2019.

Prairie Band Casino & Hotel Expansion

TGB Group is providing the Civil Engineering design for the Prairie Band Casino to add a new hotel, parking garage, administration building addition, and associated site improvements for the existing hotel and casino in the Mayetta, Kansas. We will be providing topographic survey, site/civil design services, and construction staking for project.

The 65,000 square foot parking garage will be 3 levels high, with 3 bays for each level, and can fit almost 500 vehicles.

The new 20,000 square foot hotel will have a total of 80 rooms, an indoor pool, spa, fitness center, game room, a party room, along with a high scale outdoor pool with water falls and slides.

The new 9,300 square foot Administration Building addition will connect to the casino and the existing administration building. Numerous utility relocations, including stormwater, sanitary sewer, waterlines, gas lines, electric lines, & communication lines required relocation along with parking lot and grading improvements to the site.

Many of the parking lots throughout the entire campus were regraded and new stormwater drainage design completed.

The project will be completed in 3 separate packages and TGB Group will provided construction administration for the civil work for each package. All buildings are scheduled to be complete in 2020. This will allow the Prairie Band Casino to continue to attract large events and be able to accommodate them for hotel and parking stays.

The contractor may not hold retainage from its subcontractors.

The contractor must promptly notify Metro, whenever a DBE subcontractor performing work related to this contract is terminated or fails to complete its work, and must make good faith efforts to engage another DBE subcontractor to perform at least the same amount of work. The contractor may not terminate any DBE subcontractor and perform that work through its own forces or those of an affiliate without prior written consent of Metro.
